



For best results shampoo and rinse; wait until coat is completely dry and apply Endure® Roll-On for Horses. Remove cap from bottle. May be applied around superficial wounds and abrasions or spot treat areas of the horse where flies gather. May also be applied around animal's nose, eyes, ears and mouth. Avoid direct application to eyes, nose and mouth. Replace cap after use. Repeat application as necessary but no more often than once every 5 to 7 days. Wash hands with soap and water after use.

STORAGE AND DISPOSAL: Do not contaminate water, food or feed by storage or disposal. **STORAGE:** Store in a cool, dry place inaccessible to children and pets. **DISPOSAL: If empty:** Do not reuse this container. 
